Harness, personal energy absorber, lanyards and carabiners.

Approved anchor points, travel restraint system.

Approved ladders, scissor lifts, EWPs, scaffold.

Standard PPE including safety eyewear, safety gloves, safety footwear.

Prior to starting work

Ensure all fall protection equipment complies with relevant standards and is tagged with current inspection dates.

Single person fall arrest anchor points must be capable of withstanding 15kN (1500kg).

Identify whether the work requires a fall arrest system or a fall restraint system.

Ensure fall arrest systems have a full body harness with a shock absorbing lanyard or personal energy absorbing device.

Ensure EWPs conform to relevant approved design standards.

Fall arrest systems must be worn in all boom type elevated work platforms.

If a work method requires detach and re-attach at height, a dual lanyard system must be used to ensure one connection point is maintained at all times.

Ensure working in isolation does not occur.

Tools and objects must be secured to prevent falling.

Confirm that the SWMS details the emergency response plan if a fall from height occurs, including consideration for rapid retrieval.

Ensure competency of personnel to work at height and operate equipment.

Confirm that personnel are medically capable to perform work at height. Check for epilepsy and vertigo.

Ensure exclusion drop zones have been defined and established.

Confirm recovery plans are understood and equipment is available for immediate use.

Ensure spotters are briefed and in place.

Precautions to be taken during work

Always wear the PPE required and/or provided.

When a fall restraint or fall arrest system is in use, always ensure connection to a lanyard (for personnel and tools).

If conditions or controls change, STOP, return to ground level and re-assess.

Make sure equipment and access are secure if the area is left unattended.

Completion of Work

Ensure area is free of debris and all equipment removed.
