## MANDATORY SAFETY REQUIREMENTS

Only trained and competent personnel are allowed to operate and set up/pack down the ride/device.

Operator must supervise the ride/device at all times.

If the ride/device includes moving parts, a suitable barrier must be erected to prevent access to the ride/device or users/riders. Barrier access gates must have a locking device.

Ride/device must be registered (if applicable) and maintained by competent and authorised personnel and in accordance with the manufacturer's instructions.

Safety restraints/equipment on ride/devices as appropriate such as harnesses, seatbelts, safety/soft fall mats must be used.

Ride/device must be checked each day before operation and operated run without passengers each day before operation. Records of these checks must be recorded in a log book.

Log books, operating and maintenance manuals (including emergency procedures) must be on site. Log books must include details of the erection or storage of the amusement device.

Ride restrictions as per SafeWork NSW registration and the manufacturer's specifications must be enforced including height, weight and loading capacity restrictions.

Safe public access and egress exit must be provided at all times.

Wind ratings are to be provided for externally used inflatable devices as specified by the manufacturer. This information must be included on the SWMS and adhered to by the operator.

ICC Sydney may require sign off of any structure by the manufacturer re the design and build who is qualified to do so, specifying that the structure is manufactured to any applicable standard or if not to industry best practice.
