## CONDITIONS OF PERMIT

**ICC Sydney does not permit the use of remote operated plant inside venues or at events, nor generally at other times except with written/explicit permission from ICC Sydney and appropriate safety measures being implemented.**

Remote operated plant includes drones, which are remotely piloted aircraft [RPA] under Australian legislation and their operation and safety is regulated by the Civil Aviation Safety Authority [CASA]. Remote operated plant also includes automated guided vehicles which need to adhere to the relevant safety standards and manufacturer requirements.

Using drone technology has implications for privacy. If an organisation covered by the Privacy Act intends to use drone technology it should do so in accordance with this Act. This would include giving notice to affected individuals regarding collection of their personal information, keeping it secure, and only using and disclosing the personal information as permitted under the Privacy Act.

If use of remote operated plant is authorised, then ICC Sydney must ensure that a satisfactory operational plan is in hand prior to use. This plan must demonstrate a professional requirement for the operation of the remote operated plant and a commitment to operate within the standard operating conditions set by CASA (if using drones) and the relevant safety standards and manufacturer requirements (if using automated guided vehicles).

**An Operational Plan shall include details below as a minimum:**

- The name of the operator and/or controller of the remote operated plant (who will be regarded as the responsible person)
- Details and a copy of the responsible person's current RPA Operators Certificate and/or Remote Pilot Licence from CASA as per legislative requirements in the case of drone use. If using automatic guided vehicles, then training in accordance with the relevant safety standards and manufacturer requirements.
- Details of public liability (insurance must be as per hiring agreement) and SIRA (State Insurance Regulatory Authority) NSW insurances and copies of Certificates of Currency;
- The purpose of plant operation.
- The times for commencement and cessation of operation.
- The geographical extent of the site's property to be covered during the operation.
- Identified safety hazards and the appropriate control measures to be implemented and enforced during the operation (e.g. Safe Work Method Statement; CASA operating conditions, site limitations, signage).
- Add ARN (Aircraft reference number)

- Details of personnel to be deployed to assist in ensuring the safety of the operation, including their qualifications and experience.
- Detailed risk assessment must also accompany the operational plan.

Where drone use is authorised and involves still or video photography a flight plan shall also identify potential privacy concerns and the appropriate control measures to be implemented and enforced during and as a consequence of the flight. Minimum details shall include:

- Evidence that all permissions and releases are in place.
- Specific details of who will own the intellectual property of the images.
- That the venue will have full access and if not full ownership, an unlimited licence to use the material for its own (non-commercial if required) purposes.
- General public notification must be incorporated into the operational activity of the drones.

When operating drones inside ICC Sydney, the following requirements must be satisfied:

- Line of Sight must be maintained with the RPA at all times.
- The RPA will at no time be operated over crowds of people.
- The RPA operator will have a current and valid remote pilot license (Re PL) and/or RPA operator's certificate (ReOC) as per legislative requirements.
- The RPA operator must retain manual control of the RPA at all times, RPA's under autonomous operation will not be allowed to operate within the ICC Sydney.
- RPA's must not be allowed to operate once they reach the 25% threshold for power- source depletion.

While exhibiting drones on a stand or an exhibition display the following must occur:

- The drone needs to be isolated from the public.
- The drone needs to be tethered to the stand or the ground to prevent it from reaching the public.

For any remote operated plant that is to be operated externally to ICC Sydney, the operator must contact Property New South Wales (PNSW) for the required permits for use within the Darling Harbour Precinct.

### ICC Sydney Contractor Induction

In line with the Work Health & Safety (WHS) policy at ICC Sydney, all contractors conducting work onsite will need to successfully complete a contractor induction prior to arriving on site. The induction is a simple process that can be conducted on line, please speak to the appointed event planner for your event for further detail.
